

WHO has broad mandate:

- advocating universal healthcare,
- monitoring public health risks,
- coordinating responses to health emergencies (pandemics),
- promoting human health and well being,
- providing technical assistance to countries,
- setting international health standards and guidelines,
- collecting data on global health issues,
- Serving as a forum for summits and discussions.
- What do you think WHO should focus on?

24 out of 178 health issues WHO monitors:

- Abortion, biological weapons, climate change, coronavirus disease,
- Deafness and hearing loss, earthquakes,
- Female genital mutilation, gender, health accounts
- Immunization, landslides, malaria, nutrition,
- Obesity, physical activity, quality of care, radiation,
- Sexual health, travel and health, universal health coverage,
- Vaccines, water, yellow fever, zika.

Typical Flow of Health Alerts to WHO

- 1. Doctors in hospitals or in research laboratories
- 2. National health organization (CDC)
- 3. National Government
- 4. Global health organization (WHO)
- 5. World health assembly (WHA)
- 6. United Nations Organization.

Was WHO on top of Covid-19 Outbreak?

- January 9 WHO Announces Mysterious Coronavirus-Related Pneumonia in Wuhan, China.
- January 20 CDC Says 3 US Airports Will Begin Screening for Coronavirus.
- January 28 Tedros Adhanom Ghebreyesus, the director-general of the World Health Organization, visited Chinese President Xi Jinping.
- January 31 WHO Issues Global Health Emergency.
- February 25 CDC Says COVID-19 Is Heading Toward Pandemic Status.
- March 11 WHO Declares COVID-19 a Pandemic.
- March 13 Trump Declares COVID-19 a National Emergency.

US Membership in WHO - in or out?

April 2020 President Trump:

- WHO failed stopping Covid-19 as it began to spread in China.
- Declared intention to withdraw from the organization.
- Gave 1-Year official withdrawal notice in July 2020.

• January 2021 President Biden:

- Signed an executive order to stop the U.S.'s departure.

Are there other Options without WHO?

- CDC has a global health strategy for healthier longer living.
- German Robert Koch Institute has global health strategy.
- 15 other organizations each focused on specific problems.

• **BUT**, when you have a disease that is spreading world-wide, only WHO has the ability to act as the gathering point for information on the disease, efforts to treat it, ways to prevent its spread. The CDC doesn't do that, instead CDC benefits from what WHO is doing.

WHO operates in 6 Regions

- Africa
- Americas
- South East Asia
- Europe
- Eastern-Mediterranean
- Western Pacific

Serving 194 Member Countries

Who is financing WHO?

- WHO approved 2020/2021 Budget: > \$ 7.2 Billion
- Top 3 Financial Contributors:
 - Germany 12.2%
 - Bill and Melinda Gates Foundation 11.7%
 - United States 7.9%
 - 20% mandatory, 80% donations = unstable financial foundation

. United States CDC FY 2021 Budget: \$ 7.9 Billion = stable foundation
