# Is America's Influence Declining?

# **Economics**

Now to answer the question, is America's influence in the world declining, foreshadowing the end of Pax Americana.

First we'll look at America's economic influence in the world, where we've been the dominant economic force since the second world war.




This map shows who is each country's prime supplier of imports.

Historically the USA has been a major supplier of manufactured goods to the world which, combined with a large domestic market, has driven the American economic engine.

However today most of the world imports more from other nations, primarily China, than from the US. This economic dependence can reduce America's influence in the world.


Note however that US goods have a much higher 'complexity' than Chinese goods, with the US still the world's major supplier of advanced technology and weapons.



World trade has rapidly grown over the last 2 decades, with the USA the #1 importer and #2 exporter (after China).

Our trade deficit has also grown significantly over this time, from a surplus in 1975. This is often cited as a major problem for our economy. However there are some mitigating factors:

- Inexpensive imports hold down inflation
- Foreign lenders have continued to lend the US money. This is a good thing!
- Current economic measures don't take into account added value –
   e.g. iPhone has little value added in China
- As a % of GDP, things aren't quite so dire as they look



Note rapid growth of US GDP, far ahead of others Also note Japan stalled since mid-90s Surge of China this century



While USA is #20 in per-capita GDP, it is the top 'large' country by far, others are mainly tax havens

Per-capita GDP is more than three times that of China Top countries are all democracies


In spite of much smaller population, USA has higher GDP than China & India (and than EU)

Average income highest in small countries, USA 7 times higher than China



USA already outspends other nations by far

Some nations spend much higher % of GDP, e.g. Saudi Arabia



In 19<sup>th</sup> century the UK pound was the world's default currency, but today is the US\$.

While Euro does play a role in stabilizing foreign exchange, US\$ still the strongest player by far.


This gives the US government ability to borrow money at very low rates, and keeps the US\$ higher than it would otherwise be.

Nations buying US\$ have an interest in keeping the US economy vibrant

What are some of the key pressures on USA as world leader?



USA has rising income disparity, with growth of wages at the top contrasting with stagnant wages at bottom 50%

Also note even China has a large income disparity


# **Populism**

- The idea that society is separated into two groups at odds with one another - "the pure people" and "the corrupt elite"
- On Left
  - Venezuela: President Chávez
  - Spain: Podemos party
  - · Greece: Syriza
  - · Italy: Five Star Movement
- On Right, combine with [anti-immigrant] nativism and authoritarianism
  - · France: Marine Le Pen
  - Hungary: Viktor Orbán
  - US: Donald Trump

A number of democracies are faced with pressure from groups that feel disenfranchised by the 'ruling elite'

Many right-wing populist movements blame immigrants for the woes of the masses


Putting pressure on EU, global trade, immigration



Significantly rising numbers of migrants, many internally displaced


### Causes:

- War & unrest
- Famine, some climate related



Surge in asylum seekers in the last ten years Mainly from war-torn area: Syria, Kosovo, Afghanistan,...

In addition economic migration within EU causing pressures inside EU countries – e.g. Brexit



US has had a large increase in immigration from Latin America and Asia, replacing the Europeans of 100 years ago

We have around the same % of immigrants as we did 100 years ago

# USA Is Still The Dominant Global Power

- Strongest economically
  - Largest economy
  - Advanced technology
  - Wealthiest large nation
  - Default world currency
- Strongest militarily
  - · Outspends others by far
  - Presence in most countries
  - Largest intelligence services
- Strongest political system
  - Democracies have outlasted authoritarian regimes

### **BUT**

- · Democracy under threat
  - · Populism leading to authoritarianism
  - · USA no longer shining example
- · Walking back treaties
  - NAFTA, TPP
  - · Iran Nuclear Agreement
- Inward-looking policies
  - · Weakened global trade
  - · Tariffs threaten trade wars
  - · Anti-immigrant stance
  - · Weakened diplomacy
- Rising power of China
